- 2) A Master's Degree with at least 55% marks (0r an equivalent grade in a point-scale, wherever the grading system is followed)
- 3) A minimum of eight years of experience of teaching and / or research in an academic /research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table-2.

#### Eligibility Criteria for Recruitment for the Post of Professor: (A or B)

- 1) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in appendix II, Table-2.
- 2) A minimum of ten years of teaching experience in University / College as Assistant Professor/Associate Professor/ Professor, and / or research experience at equivalent level at the University / National Level Institutions with evidence of having successfully guided doctoral candidate.
