**ELIGIBILITY CRITERIA:**

The Visiting Faculty should possess the postgraduate degree in the concerned specialty and a minimum of eight years of work experience in the concerned specialty after obtaining the postgraduate degree. The maximum age limit up to which a person can be appointed as a Visiting Faculty shall be 70 years.

**NOTE:**

1. Number of vacancies are provisional and may increase or decrease depending on actual number of Vacancies without any intimation.
2. ESIC reserves right to cancel the recruitment process at any stage at its discretion and such decision will be binding on all concerned.
3. Candidates intending to apply for multiple cadres may submit separate applications including fee.

**4. PAY & ALLOWANCES:**

- a) Honorarium (Per Day) would be paid for Adjunct Faculty in ESIC Medical Educational Institutions as per HQrs Memorandum Dated:03.09.2020.

- b) Entitlement for travel would be based on equivalent of Visiting (Adjunct) faculty designation. Further, it would be limited to actual expenditure incurred subject to production of proof of travel for a maximum of six outstation journey per year by shortest route

## 5. **TERMS OF CONTRACT:**

- a) Selected candidates shall be appointed purely on contractual basis for a period of one year, which may be extended for another one year on satisfactory performance subjected to approval of the Competent Authority.  
**The contract would be terminated in case regular incumbent joins.**
- b) Barring serious misconduct/irregularity, continuation of the incumbent would be based on satisfactory annual appraisal and approval of the Competent Authority. Other terms and condition will be applicable as issued by competent authority from time to time.
- c) The Medical Officers are required to mark attendance manually as well as on Aadhar Enabled Bio- metric Attendance System (AEBAS) daily during scheduled working days.
- d) On selection, candidate has to open an SB Account in the State Bank of India (Any branches) [This is applicable to cases where SB account is not held in State Bank of India].
- e) The Adjunct Teaching Faculty so engaged will be required to enter into a contractual agreement for the purpose on a **stamp paper of Rs.500/-**
- f) Selected candidates will have no claim for regularization of services in ESIC Hospital/Medical Institution.
- g) The appointment is subject to Medical Fitness.
- h) Official selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.
- i) The Adjunct Teaching Faculty at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated.
- j) Selected candidates have to report for joining within the date indicated in the offer of appointment to be issued after release of results, failing which the offer will be treated as cancelled.
- k) Official has to wear his/her own white coat with name badge during the duty hours.

## 6. **HOW TO APPLY:**

- a) Candidate can walk-in and register for interview from 09:00AM to 10:30 AM on **05.11.2024**.  
**No candidate will be entertained after 10:30 AM.**
- b) Application form is enclosed with the advertisement.
- c) All eligible candidates should apply through the application form enclosed with the advertisement and must fill the application form before registration process.
- d) Candidates should produce all the original documents in respect of all the parameters filled in the form during scrutiny on the day of Walk-in-Interview.
- e) Candidates are requested to report by 9 AM at the venue on scheduled dates.
- f) Please bring all following relevant Original certificates and their self-attested photocopies (1 set), 2 copies of passport size photographs and the relevant certificates issued by the competent authority in the form prescribed by Government of India, Department of Personnel & Training for consideration of reservation to the reserved candidates, failing which they will not be allowed for interview.

## **7. SELECTION PROCEDURE:**

- a) Selection will be made on basis of interview of candidates which will be conducted by the duly constituted selection board.
- b) The applications of the candidates submitted on the day of walk in interview along with the requisite fee will be scrutinized by the scrutiny committee of the Institute and only the eligible Candidates will be allowed to appear for walk in interview before the selection committee. In case, the numbers of applicants are large, the selection committee of the Institute may devise criteria for short-listing of the candidates which may include holding of a Screening Test.
- c) 50% of the total marks would be considered as the criteria for eligibility for selection.
- d) Selected candidates will have to report this office for Medical Examination and Verification of original certificates immediately after receiving Provisional offer of Appointment through email.
- e) The final selection will be based on performance in the personal interview.
- f) Offer of appointment will be provisional subject to verification of original certificates at the time of joining.
- g) The final result will be published on the website i.e. <https://www.esic.gov.in/recruitments>.

### **General Instructions:**

- (i) Mere submission of application does not confer any right to the candidate to be eligible for interview unless they report on the scheduled date and time.
- (ii) Application should be submitted in the prescribed format only. The applications submitted in any other format OR incomplete applications will be summarily rejected.
- (iii) The candidates may ascertain their eligibility and report for interview on the scheduled date and time for interview. Candidates reporting after scheduled time will not be allowed to attend the interview process.
- (iv) Wrong declarations/submission of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage in addition to suitable legal action.
- (v) On the day of Walk-in-Interview, the candidates should produce No Objection Certificate (NOC) from present employer.
- (vi) Equivalent Teaching Experience Certificate issued by DGAFMS for retired Army Medical Teachers at the time of Interview.
- (vii) The candidates who have applied for higher post may opt for lower post during the interview in the same department.
- (viii) The interview shall be conducted at the Office of the Dean, ESIC Medical College, Kalaburagi. However, ESIC reserves the right to change the venue and dates, if needed.
- (ix) Canvassing in any form will lead to disqualification.
- (x) No TA/DA will be admissible for interview or joining.
- (xi) No claim for any services like PF, Pension, Gratuity, Medical allowances, Seniority, Promotion and Leave will be admissible.
- (xii) Visiting Faculty will be assigned teaching responsibilities by the Medical College/Medical Institution concerned. Each Visiting Faculty member should conduct at least four sessions in a month, such as theory, small group discussions, practical's , community-based sessions or clinical / bed-side teaching sessions, etc., with each session of not less than 3 hours' duration. The Visiting Faculty shall not be involved in the routine administrative work of the Department and shall not replace the roles and responsibilities of the full-time faculty in the Department. Six monthly feedback on teaching by the Visiting Faculty will be obtained by the Medical College/Medical Institution.
