NOTIFICATION

New Mangalore Port Authority invites applications from eligible retired Officers (at the level of HoD) from the Major Port Sector having expertise in Traffic related matters and PPP projects for engagement as Advisor (Traffic/Business Development/PPP projects) on contract basis, initially for a period of one year, extendable by another one year. The eligibility criteria and terms and conditions are as detailed below;

I. Eligibility Criteria:

II. Terms & Conditions:

- 1. Tenure of Engagement:** The tenure of contract is for a period of 01 year from the date of joining which may be extended by another one year based on the performance of the candidate and necessity of engagement.
- 2. Emoluments:**
 - i)** A fixed consolidated remuneration per month arrived at by deducting the basic pension from the pay drawn at the time of retirement as per OM No.3-25/2020-E.IIIA, GoI, Ministry of Finance Department of Expenditure dated.09.12.20220 shall be admissible and no other service benefits will be admissible during the contract period.
 - ii)** TDS as applicable will be deducted from the consolidated remuneration as per the extant Rules /Act.
 - iii)** The amount of remuneration so fixed shall remain unchanged for the term of the contract.
 - iv)** The remuneration will be paid as per the attendance recorded. Absence without leave will be treated as "no work, no pay" and accordingly, a proportionate amount will be deducted from monthly remuneration.



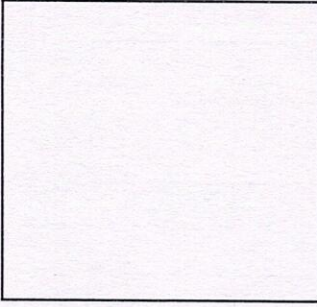
- v) Facilities such as transportation, accommodation at NMPA quarters, laptop, mobile phone, mobile plan charges, TA/DA on tour etc. will be allowed as applicable to HoD level officers.
- III. Hours of work: The selected candidate shall be required to work during the normal working hours and such extended hours as necessary for the proper discharge of duties. The selected candidate is also expected to work for additional hours depending on the necessity and urgency of work, for which no additional remuneration will be paid. The selected candidate is required to attend work on weekly off days/holidays if exigencies of work arise, for which no additional remuneration will be paid.
- IV. Leave / Holidays: 15 days casual leave in a year with the prior permission of the competent Authority.
- V. Job Role & Responsibility; act as an advisor to the ongoing and future projects, providing technical support in supervising various projects for efficient traffic management and providing expert opinion in managing the affairs of Traffic Department and PPP projects of this Port including Overall supervision of Port operations and coordination among the Port users,
- VI. Termination of contract: NMPA reserves the right to terminate the contract appointment at any point of time giving one month's notice without any liability. In the event of mis conduct, the contract appointment can be terminated by the Port without any notice and without assigning any reason. In case the candidate wish to leave the contract appointment at NMPA he/she is required to give a three (03) months advance notice in writing.
- VII. Settlement of disputes: In the event of any dispute arising out of and during the contract period, the interpretation and decision of the Chairperson, NMPA will be final and binding. Further, the court of jurisdiction for any dispute will be at Mangalore only.
